MEMBERS MATTER

Sean Frame, Sacramento County Office of Education, Chapter #480

My name is Sean Frame, and I am running for State Assembly District 6--it's the District with the Capitol in it right here in Sacramento. I am running for this seat because for far too long, our laws have been made by people who aspire to a career in politics instead of a role in serving the people of our community and state. I began my time in office because I was a parent volunteer at my sons' elementary school. When my son Everet was in second grade, his principal, my friend, was shot and killed during the school day. As a result of this tragedy, I stepped up to serve my community in a time of need; I ran for and served on the Placerville Union School District Board for nine years.

As we all know, the view from inside a school is very different from the view from the outside. I found out that 10% of our students were homeless, 70% of our students were food insecure, and 25% of our students in one school were English Language Learners. Once I learned this, I became an advocate for these students and families, and I changed my career course and took a job in education--first at the El Dorado County Office of Education and then at the Sacramento County Office of Education, where I work today as a



Multimedia Design Specialist. My wife, Ellyn, took a job as a paraeducator at a local school district.

Once I started working in education, I realized that too many of my fellow classified workers didn't make a living wage and were working two and sometimes three or more jobs. This didn't sit right with me. I got involved with my CSEA Chapter #480, and I joined our negotiations team. I became a Jacketed Steward, and I ran for and became our Chapter Communications Officer. We organized, we fought, and we won--after going to impasse, our chapter got and just ratified an agreement that will give our lowest paid siblings a raise of 18% this year with a one time bonus of 3% on top. We also increased health benefits and

stipends! Every single member got more than was on the table when we started!

What I have learned time and time again is that when we organize and we work together, we win. This is the kind of leadership I will bring to the State Assembly. Working people like us need a fearless and tireless advocate, and I will be that person for us, all of us! I have earned the endorsement and support of our statewide union as well as National Union of Healthcare Workers (NUHW.) I'm not taking a single penny of corporate money, so I will need the support of each and every person calling, knocking on doors, and contributing what they can.

PERB UPDATE: Regarding Paid Holidays and two years back pay.

I can't tell you what happened in the courtroom, so I'm going to tell you what our experience was.

November 13-15, 2023

CSEA in attendance: Sr. Labor
Representative Valerie Hollins, Labor
Representative Grayling Eation, Field
Director Jason Ter Keurst, Chapter
President Catherine Wind-Muro, Vice

San Bernardino County Superintendent of Schools in attendance: Assistant Superintendent William Roberts IV, Attorney Bill Dietrich from AALRR Law Corporation and his helper, she didn't give a name.

This PERB hearing is the chapter's first time!

November 13, was our first day: We prepped with questions and answers with our representatives. We talked about how it would be set up and what to expect.

Since this was our first time, we were all nervous. Since we live over 50 miles from the California Public Employment Relations Board (PERB) office, we decided to get three rooms at the Holiday Inn Express in Glendale, so that we were on time and didn't have to fight traffic from San Bernardino.

November 14 PERB hearing, day one: We started at 10:00 AM, CSEA called each of us in one by one. Jason went in first: his testimony was longer because he had to state our reason why we went into this hearing. We were not able to be present in the courtroom when Jason was testifying. So, we were shown to a break-out room which was an 11x8 feet room with no windows, no pictures, a very plain room; it only had seven chairs and a table. (Next time we will bring a card game).

We were then escorted back to the courtroom, one by one, and asked questions of us; first, by the CSEA Representatives. Then the County Attorney cross examined us. We ended at 3:00 PM because one of the County attorneys had to leave early -- the assistant to the Attorney.

November 15, day two: We started at 10:00 AM -- now, it was the County's time to question their witnesses, and the only witness was the Assistant Superintendent William Roberts IV.

We were not allowed to sit in the room when the Assist. Superintendent was questioned. We had to go back to our 11x8 room. The questioning of the Assist. Superintendent took about 4.5 hours and then it was lunch time.

We continued the questioning of the Assist. Superintendent after the lunch break.

Myself and Amber, were individually called back into the courtroom, to be cross examined by the County Attorney. Upon questioning of the attorney, our CSEA team asked us, individually, to clarify the question posed by the County Attorney regarding the Tentative Agreement.

We finished the second day at 5:00 PM.

Our CSEA team came out and shared with us the process of what to expect in the next couple of months.

We will be notified sometime in March 2024 regarding the outcome (verdict) of our PERB Case for holiday pay with retro back pay up to two years.

My team and I feel confident that we will win this case because it is a **Statutory Right**, and it's in the **California Education Code EDC 45203**.
