MEMORANDUM OF UNDERSTANDING

between the

FOLSOM CORDOVA UNIFIED SCHOOL DISTRICT ("DISTRICT")

and

CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION AND ITS AMERICAN RIVER CHAPTER #528 (TOGETHER "CSEA")

Comprehensive Unit **Employee Salary Range Placement**

February 28, 2023

The Folsom Cordova Unified School District ("District") and the California School Employees Association and its American River Chapter #528 (together "CSEA") are parties to a collective bargaining agreement ("CBA") which expires on June 30, 2023. The District and CSEA have met to negotiate and have agreed to this Memorandum of Understanding ("MOU") related to the placement of two (2) unit members on the salary schedule.

Employee #616980, Application Specialist - PowerSchool, and Employee #615354, Registered Nurse were incorrectly placed on the salary schedule due to the elimination of range 29 and renumbering of ranges 30-57 down one number. As a result, both employee2s #616980 and #615354 were given an additional 2.5% increase over the salary range placement of their assigned classifications.

- Employee #616980 Application Specialist PowerSchool, currently placed at Range 45, shall remain placed on Range 45 for the duration of the employee's service in the Application Specialist - PowerSchool classification. When the employee vacates the position, the position will revert to the intended Range 44.
- Employee #615354 Registered Nurse, currently placed at Range 50, shall remain placed at Range 50 for the duration of the employee's service in the Registered Nurse classification. When the employee vacates the position, the position will revert to the intended Range 49.

This shall fully and finally resolve all bargaining related to the clerical error referenced above.

This Memorandum of Understanding shall be in effect upon ratification.
