MEMORANDUM OF UNDERSTANDING #19
between
FOLSOM CORDOVA UNIFIED SCHOOL DISTRICT
and
THE CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION AND ITS AMERICAN
RIVER CHAPTER No. 528 (CSEA)

Range Increase of Food Service Series
March 20, 2024

This Memorandum of Understanding (“MOU”) is agreed to between the Folsom Cordova Unified School District (“District”) and the California School Employees Association, and its American River Chapter No. 528 (CSEA). Collectively, the District and CSEA will be referred to as “the Parties.”


The parties have met, negotiated, and agreed to the following:

1. The salary range of the Food Service Worker I will change from Range 1 to Range 3.
2. The salary range of the Food Service Worker II will change from Range 4 to Range 6.
3. The salary range of the Food Service Clerk will change from Range 9 to Range 11.
4. The salary range of the Food Service Technician will change from Range 12 to Range 14.
5. The salary range of the Food Service Office Technician will change from Range 13 to Range 15.

This shall fully and finally resolve all bargaining for the Food Service Series, through the 2024-2025 school year.

This Memorandum of Understanding shall be in effect July 1, 2024.

Cost estimated at \$142,202.99 by Nutrition program funding.
