10.25 Calendar Adjustment for Community Schools Facilitators November 20, 2024

This Memorandum of Understanding ("MOU") is agreed to between the Folsom Cordova Unified School District ("District") and the California School Employees Association (CSEA), and its American River Chapter No. 528. Collectively, the District and CSEA will be referred to as "the Parties." The District and CSEA are parties to a collective bargaining agreement ("CBA") which expires June 30, 2025.

The parties have negotiated all matters within the scope of representation and reached agreement on the 10.25 Calendar Adjustment for Community School Facilitator (Attachment A).

Rationale

Community Schools Facilitators calendar is currently 10.25 months (208 days). The District would like to align the start and end dates of the Community School Facilitators to that of the Certificated Student Support Specialist to allow for professional development days at the start of each school year. The calendar will be adjusted annually to align with the Student Support Specialist start and end dates.
